APPLICATION FOR MEMBERSHIP OF THE NATURE REFUGE LANDHOLDERS' ASSOCIATION — QUEENSLAND INC.

Before completing this Application for Membership, please carefully read the following qualifications for acceptance to the Ordinary and Associate Classes of NaRLA membership to determine which Class of membership you qualify for.

1. Admission to membership of the Association shall be conditional upon approval by the NaRLA Management Committee.

Qualifications for Ordinary membership Class

2. Eligibility for Ordinary membership of NaRLA is available to natural persons, Associations, Trusts and Corporations who currently hold an interest in land in Queensland that comprises all or part of a Nature Refuge or any other category of land subject to a Conservation Covenant attached to the Title Deed of that land, including:
- an owner or registered proprietor in fee simple of the land; and
 - if the land is leased under the Queensland *Land Act 1994*, the registered lessee of the land.

Qualifications for Associate membership Class

3. Eligibility for Associate membership of NaRLA is available to natural persons, Associations, Trusts or Corporations who meet any one of the following criteria —
- They are named as the owner or joint owner on the Title Deed, or as lessee or joint lessee on the lease, to any land in Queensland that is currently registered under the "Land for Wildlife" program; or
 - They are named as the owner or joint owner on the Title Deed, or as lessee or joint lessee on the lease, to any land in Queensland on which projects under the Australian "Landcare" program are being or have been implemented by the current owner/s or lessee/s; or
 - They are a permanent resident of Queensland and a former sole or joint owner or lessee of land in any State in Australia, which at the time it was owned or leased by the applicant for Associate membership, was subject to a Conservation Covenant; or
 - They are a permanent resident of Queensland and a former sole or joint owner or lessee of land in any State in Australia, which at the time it was owned or leased by the applicant for Associate membership, was registered under the "Land for Wildlife" program; or
 - They are a permanent resident of Queensland and a former sole or joint owner or lessee of land in any State in Australia, which at the time it was owned or leased by the applicant for Associate membership, projects under the Australian "Landcare" program were implemented on the land; or
 - They are a permanent resident of Queensland and a practising or retired professional in any field related to the conservation and protection, or research into the conservation and protection, of Australian native flora and fauna and their habitat; or
 - They are a permanent resident of Queensland and are or have been a financial member, for not less than three years continuously, of any one organisation in Australia, the primary Object of which was to conserve and protect Australia's native flora and fauna and their habitat.

Qualifications for Open membership Class

4. Eligibility for Open Membership is available to any individual, Association, Trust or Corporation who has an interest in land that is being managed to enhance biodiversity, or whose current (or past) professional interests or memberships are aimed at conserving and protecting Australia's native flora and fauna and their habitat. This category of membership does not include voting rights, but otherwise Open Members are entitled to all other NaRLA services.
